ORDER

The Appellant filed his 2nd Appeal before the Commission on 23.05.2007. The facts that led to the 2nd appeal can be summarized as follows:

The Appellant had submitted an application for information to the PIO, Health & Family Welfare Department, Secretariat, Thiruvananthapuram on 1.09.2006.

It was recorded as received on 3.10.2006 and it was lying in the section (J) till 18.10.2006. However, a reply was seen given to the requester on 10.11.2006 stating that since the order was issued, it was not possible to furnish the requested details. And, not satisfied with the reply the requester went on first appeal on 28.12.2006. There was no reply to it, hence the second appeal.

On receiving the second appeal the Commission called for a detailed report from the Appellate Authority. The report was submitted on 30.07.2007. In the report it was stated that the information sought was furnished on 30.05.2007.

The Commission carefully examined the report and decided to hear the PIO/PIOs. The Commission summoned them for a hearing on 22.12.2007. Smt. Susamma, Retired Additional Secretary, Health & Family Welfare Department, Secretariat, Thiruvananthapuram was present and heard. She said that she retired on 31.10.2006. She submitted that a lot of confusion arose out of a wrong information given by the requester. The requester had referred to a file No. 15427/FW2/2000 in his request. But in his appeal, he had indicated the same as 15427/F2/2000/LD. The second was the correct one. And it took some time to get it properly sorted out, she submitted. Once it was sorted out on 14.5.2007, the information requested was sent to the requester free of cost on 30.5.2007.

The Commission find that the confusion that caused the delay was due to the wrong reference. Once it was cleared the PIO concerned had acted promptly. Since the information is seen furnished, there is no cause for the Commission to interfere.

The appeal is disposed of accordingly.

ORDER

The Appellant filed his 2nd Appeal before the Commission on 30.05.2007. The facts that led to the 2nd appeal can be summarized as follows:

The Appellant submitted an application for information to the PIO, Office of the District Educational Officer, Kottarakkara on 26.02.2007 asking for some information connected with the appointment of Aby Philip as U.P.School Assistant. It was replied to on 26.3.07. Not satisfied with the reply he filed the first appeal on 13.04.07. The first appeal was replied to on 2.5.07. The appellant was instructed to take back the cheque and remit the necessary amount. He was informed that the documents asked for will be issued on

remittance of money. It was against this order he submitted his second appeal.

The Commission asked for a detailed report. The report was submitted on 31.07.07. In the report it was made clear that the documents asked for were furnished on 25.6.07.

There was no delay in furnishing the information. Therefore there is no cause for any further interference from the commission. So the appeal is disposed of accordingly.

ORDER

This is a second appeal filed before the Commission by the appellant on 08.03.2007. The facts leading to the Appeal can be summarized as follows:

The appellant made a request to the Public Information Officer of the Office of the Director of General Education on 22.09.2006. He asked for some information regarding the representation made by a teacher. On 04.10.2006 the appellant was informed to remit the fee as decided by the Government. And he was given the information asked for on 17.11.2006.

Since some part of his application was rejected he filed the first appeal before the Appellate Authority on 12.12.2006. The Appellate Authority informed him on 29.03.2007 and again on 12.04.2007 to come to the Public Authority to inspect the file. But the Appellate Authority subsequently informed the Commission in its report that he did not turn up.

On receiving the 2nd appeal, the Commission asked for a report from the Appellate Authority. The Appellate Authority in its report filed before the Commission on 19.05.2007 informed the Commission that inspite of repeated intimations, the appellant has not turned up to inspect the file referred to.

The Appellate Authority also assured the Commission that it would again make the same offer to the appellant.

The Commission examined the 2nd appeal and the report of the Appellate Authority very carefully. The Appellate Authority has already granted the request made in the 2nd appeal. Besides, it has informed the Commission that it will make the same offer once again to the appellant. It is upto the appellant to decide whether he should make use of the opportunity or not. The Commission is not inclined to do anything about it. No further intervention is called for in this case.

The appeal dismissed.

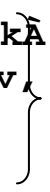
